This meeting is for discussion pertaining to the upcoming Ordinances, Resolutions, and discussion items of the Public Service Committee for review as follows:

1. Approval of Minutes of June 14, 2021

Ordinances

1. **Ordinance No. 2021-72**–Introduced by Council – An Ordinance waiving the residence requirement of the Directors of Public Safety.
2. **Ordinance No. 2021-73** – Introduced by Council – An Ordinance authorizing the issuance of notes in the amount not to exceed \$1,525,000 in anticipation of issuance of bonds for the purpose of funding a portion of the cost of acquiring, constructing, installing, and equipping public infrastructure improvements necessary for the development of the National Road Business Park, including an access road, waterline extension, and sewer line upgrades and extension, and all necessary appurtenances thereto, and retiring notes previously issued for such purpose, and declaring an emergency. (Emergency or First Reading at Council)
3. **Ordinance No. 2021-74** – Introduced by Council – An Ordinance authorizing pay increases based on enhanced certifications in the Traffic Signal Department. (First Reading at Council)
4. **Ordinance No. 2021-77** – Introduced by Council – An ordinance authorizing the proper city official to apply for a WSRLA Loan for the Mitchell Hill Water Storage Tank 3 project or Pioneer Reservoir Replacement.
5. **Ordinance No. 2021-78** – Introduced by Council – An Ordinance authorizing the Public Service Director to advertise for bids and enter into a contract with the lowest and best bidder for the Mitchell Hill Water Storage Tank 3 project by replacing the Pioneer Reservoir facility.
6. **Ordinance No. 2021-79** – Introduced by Council – An Ordinance authorizing a cooperative agreement with Falls Township for the OPWC application.
