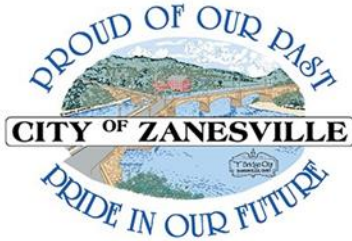

TRAFFIC ORDERS

Traffic Order 2022-01

- SECTION ONE: No Turn on Red from northbound Maple Avenue into Walmart private drive.
- SECTION TWO: No Turn on Red from Walmart private drive northbound onto Maple Avenue.
- SECTION THREE The appropriate signs shall be installed in accordance with O.R.C. 4511.09.

Traffic Order 2022-02

- SECTION ONE: No Turn on Red from Staple's private drive onto northbound Maple Avenue.
- SECTION TWO: The appropriate signs shall be installed in accordance with O.R.C. 4511.09.

Traffic Order 2022-03

- SECTION ONE: There is hereby established a No Parking Anytime Zone on the south side of Smithfield Avenue from Maysville Avenue west 180'.
- SECTION TWO: The appropriate signs shall be installed in accordance with O.R.C. 4511.09.
