7. **Ordinance No. 2022-130**– Introduced by Council – An Ordinance amending the schedules to Ordinance No. 2022-68 that established wages for unaffiliated employees in the municipal service, establishing addition of job classification. (First Reading)
8. **Ordinance No. 2022-131**– Introduced by Council – An Ordinance authorizing a maximum schedule of positions for the City of Zanesville’s workforce. (First Reading)
